By signing of this form, in consideration of the concrete methods of carrying out the event, please undertake to:

- A. keep the FMI and the Moto Club Paolo Tordi harmless from any consequences connected with any damage of any kind suffered by the team or the rider.
- B. Relieve the FMI and the Paolo Tordi Moto Club from any liability resulting from any damage suffered connected to the state of maintenance of the track, the areas connected to it and the related equipment.
- C. Read the rules and precautions to be observed by those who use the track, the areas connected to it and the structures connected to the same in which the tests and races take place and to accept them unconditionally;
- D. Read all the conditions in force for the use of the track in which the individual tests and races will take place and accept them unconditionally;
- E. Wear suitable clothing and protections, in accordance with the regulations in force;
- F. Get off the track only if in perfect physical and mental health, relieving FMI and the Paolo Tordi Moto Club from any responsibility for any physical problems that may arise during the course of the activity;
- G. Do not give any document or title valid for access to the route and the areas connected to it to anyone else, assuming, in the event of non-compliance, any related liability, including for any damage that may occur to third parties.
- H. Finally, we undertake to compensate for any damage caused directly or indirectly to the FMI and the organizing Moto Club, to the structures, to the track and to the areas connected to it, to the other drivers and their vehicles, to third parties, whether they spectators or members of the organization if and to the extent that said damages are attributable to malicious behaviour.
